Administrative/Biographical History

Lew Dakan (1907-2000) Mr. Dakan had a photographic studio that operated in Greeley, Colorado from 1948 until 1992. He was born December 11, 1907 and died September 23, 2000. His interest in photography began in 1927 when he was working as a surveyor for AT&T. While attending the University of Colorado, aerial photography was included in his Civil Engineering studies, and thus began a lifelong interest in aerial photography. He was named the first qualified aerial photographer in the western United States in 1970 by the Photographers of America.

Scope and Content

Collection of photographs and negatives. Images of Weld County, primarily aerials, including major construction projects such as Kodak in Windsor and the Weld County Centennial Center Complex in Greeley. Some portrait and still life photographs also included.
