Administrative/Biographical History

Brief History on the Historic Preservation Office

The City of Greeley Historic Preservation office is dedicated to preserving historical properties and areas around the district. Many of these buildings contributed to Greeley's history through their historical, architectural, and/or geographical significance.

Brief History of Normal Haven

This house, located on 1514 9th Avenue in Greeley, CO, was first owned by John B. Evans who was the proprietor of Normal Haven, a boarding house for Colorado State Normal School (later University of Northern Colorado) students. For room and board, Females paid \$2.00 per week and males paid \$2.25, ostensibly because they ate more. A variety of other people lived in the house over the years including Rufus A. Kauffman, a retired farmer, and James M. Baker. Kauffman was the son of D. M. Kauffman, a Greeley pioneer. Rufus came to Greeley 1873 and died in Greeley in September 1927. He was a member of the Odd Fellows Lodge and the Unitarian Church.

Normal Have is a Colonial Revival style residence; it has a two-story wood frame structure with a composition shingle, hipped roof. The main façade is broken into three bays and contains a centered entrance.

Brief History of John T. Watkins House

John T. Watkins was the first owner of the bungalow, built in 1922 and he and his family lived here for over 20 years beginning in 1922. He was a farmer and later managed the E & H Auto Shop before starting his own service station, Watkins Service Station. The building was later divided into apartments.

This Craftsman style bungalow residence is located at 1217 9th Avenue. Roof features include centered dormers on the east and west elevations and exposed rafter ends. It has a concrete foundation and wood lap siding and stucco exterior.

Brief History of the Pitts Smith House

The home was built in 1907-08 for Pitts Smith and his family by local architect and builder Charles Chandler. After coming to Greeley in 1871, Mr. Smith became a successful farmer despite trials with grasshoppers, hail storms and rattlesnakes. He lived with his wife Almina, daughters Cora, Amy and Luna. Luna graduated from the State Normal School and taught at several local schools. She was later the principal of both Horace Mann and Cameron school.

The Pitts Smith house is an American Foursquare residence at 1513 9th Avenue. It has a squareshaped, two-story wood frame structure with a composition shingle flared hip roof. Roof features include boxed eaves, a hip-roofed dormer on the east and two shed roof dormers on the south and west elevations.
